ORDER

The Government, in their G.O.Ms.No.394-414, Higher Education Department dated 7.12.2007 and G.O.Ms.No.421-422, Higher Education Department, dated 14.12.2007 have issued orders for the appointment of the candidates selected by the Teachers' Recruitment Board under Direct Recruitment for the year 2006 – 2007 as Lecturers in various departments of Government Arts and Science Colleges and Colleges of Education.

2. The Director of Collegiate Education has sent proposals for the regularization of the services of these 900 Lecturers belonging to Tamil Nadu Collegiate Educational Service. The Director of Collegiate Education has therefore requested the Government to regularize the services of 900 Lecturers (Re-designated as Assistant Professors) with effect from the date of their joining in the post.

3. The Government have examined the proposal carefully and have decided to regularize the services of 900 Lecturers now Re- designated as Assistant Professors who are fully qualified to hold the post of Lecturers (Re- designated as Assistant Professors) mentioned in Category I and II of Class VII in Tamil Nadu Collegiate Educational Service.

4. Accordingly, the Government regularize the services of 900 lecturers redesignated as Assistant Professors mentioned in the Annexure with effect from the date of joining the post as specified against their names.

5. The Director of Collegiate Education is requested to send necessary proposals for declaring their probation as and when these 900 lecturers (Re-designated as Assistant Professors) complete their period of probation in due course.
