ORDER:-

In the G.O.1st read above, orders were issued for the continuance of 3638 posts of Teaching and Non-Teaching Staff in the Government Arts & Science Colleges for the period from 1.1.2010 to 31.12.2011. The Director of Collegiate Education in her letter 2nd read above has stated that all the above posts were created for normal increase of workload and are necessary for the day to day affairs and smooth functioning of the colleges and requested the Government for the further continuance of 3638 posts for 4 years from 1.1.2012 to 31.12.2015.

2. The Government, after careful consideration, accord sanction for further continuance of the 3638 temporary posts of Teaching & Non-Teaching Staff working in Government Arts and Science Colleges for a further period of 2 years from 1.1.2012 to 31.12.2013 which were originally sanctioned and last continued in the Government orders mentioned in the Annexure to this order.
